1. The structure of the site shall be according to our commonly advertised:
 - Website Simple
 - Website 5
 - or Website 10 page structures.
2. Hosting costs are clear and include monthly maintenance and, for one time per month, upgrading of any copy, revision of images and/or testimonials if required.
3. The Websites are optimised for Desktop, Tablet and Mobile.
4. 'What we need from you' details are specified and what is required completely for work to commence. It is important that we have all content supplied. [See *sending files to us*]
5. A deposit of 50% is required, together with signed agreement, before work commences.
6. The Website will be built and hosted on a staged site (mock) until finalised.
7. Once finalised the Website can be livened up on our hosting facilities, or transferred to another hosting facility at your request.
8. The balance of agreed amount is to be paid within 3 working days of site going live, or an agreement is finalised on design and functionality.
9. Extra functionality and services, such as google analytics, upgraded security if requested and other added features costs will need to be settled in full upon going live
10. Unpaid invoices: If any invoices remain unpaid after 7 days according to our terms, NZFCD may
 - a. Withdraw hosting
 - b. Charge the customer default interest on any unpaid amounts of 2% per month
 - c. Charge the customer all collection and related fees
11. Force Majeure: NZFCD will not be liable for any failed hosting or data loss due to circumstances beyond our control.
12. **No waiver:** If at any time NZFCD does not enforce any of these Terms and Conditions or grants the Customer time or other indulgence, NZFCD shall not be construed as having waived that term or condition or its right to later enforce that or any other term or condition.
